It was apprised to the Committee members, that in response to the said tender notice total 06 (six) nos. of bids were received in sealed envelope upto the last date of submission of bids i.e. 29/06/2018 till 02:00 PM from the following Bidders:-

As per the Pre-bid Committee decisions and the same placed on University website, the bids of M/s. Mehta Enterprises, Patna and M/s. Mex Service, Patna were not considered as they have neither participated in last tender nor attended the Pre-bid meeting dated 23/06/2018.

The sealed envelope of all the bidders except M/s. Mehta Enterprises, Patna and M/s. Mex Service, Patna were opened in presence of CPC members and the re-
