- (x) I state that the information regarding my personal details provided to the University and filled by men in hostel application form is correct ot the best of my knowledge and belief.
- (xi) I also give undertaking that if I am found guilty by the hostel authority, directly or indirectly, individually or collectively or in a group of two or more students or persons in any of the following acts, then my admission in the hostel will be cancelled and/or appropriate punishment will be given to me:
 - (a) Disobeying the instructions of teachers or the authorities;
 - (b) Misconduct or misbehaviour of any nature at the time of elections to the student bodies or at meetings or during curricular or extra-curricular activities of the University/ hostel;
 - (c) Physical assault, threat to use physical force, or any other intimidatory behaviour, within the premises of any institution of the University system, or of any unit of any such institution, against any teacher, officer, functionary, member of any authority or other body, member of the non-teaching staff, or student of any such institution or unit, or a visitor present on official invitation or for administrative or academic work in such premises;
 - (d) Any act or statement, or distribution or display of any document or literature, including the circulars, pamphlets, posters, press releases, cyber defamation etc., which adversely

- (i) Any act or practice, whether verbal or otherwise, that is derogatory of women or amounts to sexual harassment;
- (j) The making of false statements or the submission of false dicuments;
