Vacancies occurred due to cancellation/withdrawal will be filled from wait list in order of merit.
- In case a candidate does not secure her/his name in any of the list of admitted student, the full programme fee will be refunded to her/his bank account after **March**, **2023**. However, registration fee amounting to Rs. 500/- for Gen/OBC/EWS and Rs. 200/- for SC/ST will not be refunded.
