After briefing the attendees about the 14-point recommendations made by the Peer Team of NAAC during 1st cycle accreditation, the items of the agenda were deliberated upon and resolutions made. The following items of the agenda were taken up in the meeting:

Agenda No. 01/IQAC-10/21 Confirmation of minutes of the previous meeting.

Resolution Minutes of the 9th meeting held on 16st July, 2021 were circulated amongst the members. As no comments/suggestion's/observations were received, IQAC unanimously resolved to approve the minutes of the 9th meeting.

Agenda No. 02/IQAC-10/21 Action taken on decision made in the 9th IQAC meeting.

Point wise discussion related to all the points as stated in Annexure 1 was done in detail in 10th meeting. It was resolved that many of the recommendations have already been fulfilled in the previous year which include, initiating an active NSS unit, funding to set up high end equipment in CIF to support quality research, initiation of MoU's with other institutions, etc. However, the members insisted on a forming Alumni Association, constitution of IIC in the university, exploring consultancy potential and starting a greater number of skill-based courses in various departments in the coming year.
