
Plan of Action based on Analysis of feedback

The aim of the student feedback collection is to get opinion on the curriculum of the offered programs specifically on the attainment of Program Specific Outcomes (PSOs) and Course Specific Outcomes (Cos) and other parameters such as fundamental topic in the syllabus, relevance of the course, extend of course coverage during each semester etc. Feedback from other stakeholders includes questions related to every aspect important for holistic learning and professional development of students and infrastructure of the university.

The feedback collected is analyzed to improve upon the course curriculum and other infrastructure facilities. The feedback data is shared with every department to discuss and deliberate upon suggestions at the level of departmental committee, and suitable suggestion are being discussed and deliberated in the BoS meeting. The course curriculum approval and adoption process of CUSB is given below:
