**ADMISSION NOTIFICATION FOR DBT SUPPORTED POSTGRADUATE PROGRAMME IN BIOTECHNOLOGY: ACADEMIC YEAR 2023-24**

Applications on the prescribed format are invited through online mode from the eligible candidates (GAT B-2023 qualified) for admission to DBT supported M.Sc in Biotechnology programme for the academic session 2023-25.

2. Admission shall be made on the basis of merit (GAT-B score) obtained through **Graduate Aptitude Test-Biotechnology (GAT-B 2023)** conducted by the National Testing Agency (NTA) through DBT Regional Centre for Biotechnology (RCB), Faridabad - 121001 for the year 2023,

**3. Eligibility Criteria for admission :**

*Bachelor's degree in Biotechnology or any branch of Biological Science (Microbiology/ Biochemistry/ Bioscience/ Environmental Science/ Biomedical etc.) or B.Sc. (Hons) in Zoology/Botany/Chemistry or B.Sc. / Integrated B.Sc. B.Ed. of three year duration with any of the two subject among Zoology, Botany & Chemistry in 3rd year with a minimum of 55% marks for General / OBC/EWS candidates and 50% marks for SC/ST/PWD candidates from any recognized University.*

5. Candidates who are desirous to take admission in M.Sc. Biotechnology programme offered by Central University of South Bihar for Academic Year 2023-24 are required to register themselves on CUSB Portal through **SBI E-collect** (go to SBI E-collect → choose state as Bihar → choose Educational Institution as Central University of South Bihar → Pay Registration Fee for DBT Student) by paying the registration fee (non-refundable) amounting to Rs.500/- for Gen/OBC/EWS and Rs.200/- for SC/ST/PWD from **04.08.2023 to 10.08.2023**. For registration process, fill [Google Form](#).

6. The candidates are required to check the eligibility criteria before applying for admission to DBT (GOI)-supported M.Sc. Biotechnology program at the Central University of South Bihar.

7. Admission to M.Sc. Biotechnology program will be done solely on the basis of the valid **GAT-B score/rank (conducted by NTA through the Regional Centre for Biotechnology (RCB), Govt. of India)** of the candidate.

8. A category-wise waiting list will be prepared **as per the merit of GAT-B score** and displayed on the University website (refer to the admission schedule for dates).

9. However, deposition of programme fee shall not guarantee the provisional admission in programme. Provisional admission will be granted strictly in order of merit and subject to fulfillment of eligibility criteria.



10. Candidates should ensure before registration that they have appeared in the test for the specified Programme.

11. It is to be noted that only those candidates can deposit the full programme fee who have registered themselves for admission by paying registration fee as mentioned above within the stipulated timeline and uploaded all the requisite documents ( **as per Annexure-3**).
